Thank you for your Official Information Act 1982 request, received on 13 January 2025. You requested:

On 11 February we extended the timeframe for responding to your request by 20 working days because the consultations necessary to make a decision on your request were such that a proper response to your request could not reasonably be made within the original time limit.

SIA has identified 20 documents in scope of your request, as detailed in the attached Document Schedule. Please note, some information has been withheld under the following sections of the Act:

9(2)(a)	to protect the privacy of natural persons, including that of deceased natural persons;
9(2)(f)(iv)	to maintain the constitutional conventions for the time being which protect the confidentiality of advice tendered by Ministers of the Crown and Officials; and
9(2)(g)(i)	to maintain the effective conduct of public affairs through the free and frank expression of opinions by or between or to Ministers of the Crown or members of an organisation or officers and employees of any public service agency or organisation in the course of their duty.

Regarding section 9(1) of the OIA, I do not consider that the withholding of this information is outweighed by public interest considerations in making the information available.

Recent and upcoming engagements

Advice on engagement and bringing a range of perspectives to our work

You have asked for advice on how we might engage more systematically with a range of stakeholders on our work – and also to support you to do the same. We are considering the best way to continue to bring key voices and technical expertise to bear on our work, for example through technical reference groups and regular forums. We will brief you on this in the next fortnight.

Recent engagements

Last week we had stakeholder meetings with the Chief Science Advisors, the Co-Chairs of Te Pūkotahitanga (the tangata whenua Ministerial Advisory Group for the National Strategy to Eliminate FVSV), the Ākina Foundation, New Zealand Council of Christian Social Services, Community Housing Aotearoa, the Social Service Providers Association (SSPA) and the New Zealand Society of Actuaries. All are enthusiastic about being engaged and are keen to provide input as social investment develops. SSPA is considering how it can provide a few forums for useful direct discussions with providers on social investment, including for you to speak directly to and hear from providers.

Upcoming iwi engagements

The Iwi Chairs Forum was held this Thursday and Friday in Auckland, hosted by Ngāti Whātua Ōrakei. A workshop session on social investment for a smaller group of Iwi Chairs, facilitated by Willie Te Aho, is scheduled for next Wednesday. We have indicated our availability to be involved in as much of the discussion as they would like.

We are also participating in a workshop session with the Executive Team of Ngāti Toa, have a regular relationship hui with Ngāi Tahu, and continue to meet regularly with Te Hiku o te Ika.

Impact and Value Measurement Standards

Implementation of the standards

We are currently testing the standards in our review of spend and will be reporting back to you on two priority areas in our report this week.

We also met with Chief Science Advisors last week to test the standards with them. Their overall feedback was positive. They stressed the importance of building evaluation capability and measuring the right outcomes. Chief Science Advisors from outside of the social sector also showed a keen interest in applying the standards to their context.

The Social Sector Commissioning and Procurement Committee (comprised of tier 3 and 4 procurement managers across the social sector) invited us to their monthly hui to present the standards. We asked the Committee to consider implementation of the standards in their context and to send us feedback based on their experiences of working/contracting with providers. The Committee is also keen to have us present on other social investment pieces as we progress our work.

We are considering the best mechanisms to support implementation of the standards (eg, Cabinet agreement, via Budget processes etc).



Social Investment: evaluating social sector spending

Insights on attendance

We have now completed the substantive work looking at the future outcomes of students who are referred to the Attendance Service. At a high level, we are seeing:

- Attendance Service participants experience an increase in their short-term attendance after
 they get referred, but there is evidence this begins to fade out over the next six months. The
 attendance increase is not as large as the increase for a matched group of students who are
 similar in terms of their demographics and their prior attendance history.
- Attendance Service participants go on to have relatively negative outcomes in later life, across educational attainment, employment and income, housing, victimisation and contact with the criminal justice system. For example, only 16% of participants referred because of non-enrolment (and 29% of those referred because of chronic absence) go on to achieve NCEA Level 2. About 5% are in emergency housing by the age of 22 (relative to a population average of 0.4%).
- Attendance Service participants have noticeably worse later life outcomes than those
 experienced by a group of people we matched them to. This matched group is similar across 98
 different demographic and socio-economic characteristics, but may not be the same on aspects
 we can't observe in the IDI (such as whānau attitudes towards attendance, or the presence of a
 positive mentor in school or in the community)

We are currently discussing these results with the Education Review Office and the Ministry of Education, who are synthesizing these findings with the results of other analysis, including surveys and interviews of students, whānau, schools and Attendance Service providers. Broadly speaking we are seeing a lot of alignment between the strands of evidence. We expect some advice on preliminary findings and recommendations to be coming to Associate Education Minister Seymour in the next several weeks. We will brief you on the findings at the same time.

Aroturuki Tamariki | Independent Children's Monitor analysis

SIA has a cost recovery arrangement with Aroturuki Tamariki | Independent Children's Monitor to support their first annual report on outcomes of the tamariki and rangatahi Māori who have experienced the Oranga Tamariki system, and their whānau.

We have shared initial insights with the ICM from a first tranche of selected employment and education indicators from the IDI. ICM was highly interested in the initial findings. The data indicates that employment and education outcomes are much poorer for Māori adults with experiences of Youth Justice and/or Care and Protection custody, compared to those with lower-level interactions with the system (such as a Report of Concern or Family Group Conference). The data also indicates very low Level 2 educational attainment for Māori 18-year-olds with recent Youth Justice custody or intervention.

The discussion confirmed our approach and we will continue to provide further data and insights on outcomes and experiences across a wide range of domains (such as education, employment, justice, corrections and health) for tamariki and rangatahi Māori who are currently in the system and adults who have now left the system.

We expect this analysis to be a useful input to other work, including in our spending reviews, insights on targets, and in providing advice on when and how to intervene earlier and more effectively in the lives of those who are most vulnerable.



MSD sought comment from SIA on proposals in the name of the Minister for Social Development and Employment focused on the government's work programme to reduce benefit dependency. The proposals were presented in two papers: Paper 1: An overview of changes proposed or underway, including seeking decisions on the Traffic Light System, Non-Financial Sanctions and requiring Jobseeker Profiles Paper 2: Detailed information and decisions on the 26-week reapplication process for Jobseeker Support.	We recommended that the proposals outlined in the draft papers would be strengthened if a plan to monitor and evaluate the impact the proposed changes was indicated. We also noted that the papers could be strengthened if other elements of a social investment approach could be more clearly demonstrated. While desired outcomes were clear, other elements of social investment (as included in your social investment checklist) were not well articulated.
Suicide Prevention Action Plan	The paper seeks agreement to release a draft suicide prevention action plan for public consultation. Current activity is guided by the Every Life Matters – He Tapu te Oranga o ia tangata: Suicide Prevention Strategy 2019–2029 and the associated Suicide Prevention Action Plan 2019–2024. With the action plan coming to an end, the intention is for a second action plan to guide suicide prevention efforts during the remaining five years of the suicide prevention strategy. SIA did not have substantive comment on the paper.

Social Investment Ministers meeting

The Social Investment Ministers Group is next scheduled to meet on **10 September 2024**. We will work with your office to prepare an agenda and relevant papers.

Options for the agenda include (suggest 2-3 items from the below list, with the first three being our recommended items):

- Impact reviews an update on the approach to the reviews of the impact of spend that the Social Investment Agency is leading, possibly with some initial findings
- Social Investment Fund an overview of the parameters being considered for the design of the Fund
- Showcase an approach to social investment being taken within a portfolio Ministers are implementing the framework and may be keen to share and test their approach (eg, Minister of Education)
- Data infrastructure an overview of the plan to improve the data infrastructure needed for social investment (as well as an update from Stats on progress to get data into the IDI). This update could provide an overview of the approach to the planned Cabinet report-back invited by 1 October (we expect to have initial advice to you on this work on week beginning 18 August)
- Social investment implementation framework a (brief) discussion of the implementation framework that the Agency is developing to guide work to implement social investment ('Lead, Build, Do'), building on the work programme Ministers considered at their last meeting.

Based on your feedback, we'll provide you with a draft agenda for discussion at our next officials' meeting.

Recent and upcoming engagements

Last week we hosted representatives from Ngāi Tahu and are discussing an ongoing work programme with them. We also presented on social investment to the leadership team of Te Runanga o Toa Rangatira, with very strong interest in this kaupapa from their leadership

We presented on the Regional Data Tool to the Auckland Regional Leadership Group. The audience included representatives from iwi, Auckland Council and the Tāmaki Makaurau Recovery Office. There was great interest in the tool and also from iwi representatives to work with SIA in the future.

We presented to the Aotearoa New Zealand Evaluation Association (ANZEA) Wellington branch meeting, and met with the Children's Commissioner and the Auditor-General. We have also met with key social investment experts to discuss data infrastructure.

We have also had follow-up conversations with Genesis Youth Trust to learn more about their experience of Social Impact Bonds, and with Ghandi Nivas to understand more about their contracting concerns. Both follow-ups were positive.

Outcomes-based contracting standards

- Information and findings from a recent stocktake of contracts
- An overview of social sector commissioning, progress made towards outcomes based contracting and barriers/gaps.

Value and Impact Measurement Standards - implementation and uptake

Following the distribution of the Social Investment Checklist and draft Value and Impact Measurement Standards to some government agencies, we have heard that Ministry of Transport is using the Standards to assess the quality of the evidence base that underlies their investment approach. We have offered to support them in implementing the standards in their work, and requested feedback for how we could further refine the standards (before or after they are more widely released). The Ministry of Education is also already applying the social investment framework and standards to its work, and has asked for our assistance to do so. The Ministry for Housing and Urban Development is also using the framework and standards to guide its approach to an outcomes-based contract (and which we are supporting them with).

We consider this as evidence that the framework and standards are filling a critical gap in helping agencies to think about evidence-based investment decisions; that they are practical and not daunting for agencies to attempt to use; and that they can potentially be applied to contexts (such as transport) that are outside of the traditionally defined social sector.

Strategic Insights for Government Targets

As discussed with you, we are supporting the DPMC Delivery Unit's quarterly reporting on Government Targets. We will initially leverage data currently in the IDI and available for other work we have done. Accessing up-to-date data, either directly from agencies or within the IDI is critical to the value of this work in supporting Ministerial decision-making and prioritisation. This will require working closely with both the Delivery Unit, Stats NZ and agencies to make data availability a priority.

We expect this work will demonstrate how social investment can strengthen delivery against the targets through:

- Providing a deeper understanding of the different target populations impacted by each target and the extent to which they overlap (and where opportunities for early intervention are)
- Identifying and quantifying cross-cutting populations of relevance for multiple targets
- Analysing geographic disparities in performance against the targets.
- Exploring 'what it will take' to meet the targets in relation to all of the above.

We believe that our Social Investment standards and guidance may also have a role in the further development of target Delivery Plans. We are working with the Delivery Unit and other central agency partners to incorporate this thinking into planning processes.

Social Investment: evaluating social sector spending

Impact of social sector spend

Following your approval of our proposed approach to the review of impact of spend, we continue at pace to refine our analysis. We have provided your office with draft letters to send to your colleagues, which will strengthen buy-in and mandate for these reviews.

As this is a new process (for ourselves and agencies), issues we are encountering and are working through with agencies include:

- Getting clear on who is 'leading' the reviews (or whether they are being done jointly) —our current approach positions us as leading on advice relating to the evidence of impact, but ensuring the partner agencies are clear that they can continue to advise on how to integrate this advice within the two strategies they have responsibility for; and
- How to best balance what is implied by the evidence of effectiveness with operational considerations such as existing contractual arrangements and capacity within regions to further scale up programmes.

Insights on attendance

We recently completed our final piece of work supporting the Education Review Office (ERO) with their review of the attendance service. Our analysis investigated which social factors outside of the education system are most influential to student's attendance. Attached to this report is a slide deck providing an overview of our findings.

We found the key factors associated with increased attendance were:


- Previously participating in early childhood education
- Having a mother with higher education attainment.

We also identified a number of factors that decreased the odds of regular attendance. A number of these align closely with Government Targets. Students are less likely to attend regularly if they:

Have a record of offending (Government Target)

- Have been a victim of crime (Government Target)
- Live in social housing, or emergency housing (Government Target)
- Live with a family member who receives any type of benefits (Government Target)
- Had visited the emergency department in the last year (Government Target)
- Access mental health and addiction services, or have parents who had access these services
- Have been diagnosed with autistic spectrum disorder
- Had an OT investigation
- Live in high deprivation areas.

We also found that while attendance is 'sticky', and past non-attendance predicts future non-attendance, there are also many students who vary in their attendance patterns over time. For example, of the students with irregular attendance (attending 80-90% of the time) in 2018, only a third continued to have irregular attendance in 2019. The remainder were roughly evenly split between those who increased their attendance to regular, and those whose attendance dropped off. Students whose attendance dropped off were more likely to experience the above factors.



This work helps to highlight relationships that exist between the Government Targets, which we intend to discuss with DPMC, and feed into our strategic insights relating to the targets.

While we do not currently have any additional work planned with ERO specifically on attendance or the attendance service, we are currently discussing with them how we can support their work in NCEA achievement.

Publishing underlying data for previous work

In June 2023 we published information on outcomes for young people in Alternative Education. We have received a request for the underlying data relating to that work to inform the requester's applications for (initially) philanthropic funding of various initiatives to assist students to stay in school. The requester has also asked whether we conducted any analysis on the fiscal cost to government associated with Alternative Education, which we did but never published

In addition to responding directly to the requester, we propose to add tabular data (ie, an excel spreadsheet) to the relevant publication page on our website, alongside what has already been publicly released in graphical form. We also propose to publish the fiscal calculations given there is likely to be broader interest in this information. This adds to the findings of the previously published report by showing the extent to which later life outcomes for those who participate in Alternative Education are costly for government and society (and the individual).

Social sector commissioning information request

Your Office recently reached out to Minister Upston's Office with a request for information relating to social sector commissioning. This request was focused on:

- Some basic stats about how many contracts are held with how many providers (and therefore how many contracts with agencies each provider holds).
- Information about where the social sector commissioning/relational commissioning work is at – recent activities and progress, what is planned next, and where it's all going.

We understand that the first part of this information request has been addressed, with the second half planned to be addressed shortly (to coincide with advice MSD are currently preparing for Minister Upston).

MSD have provided information about a stocktake of Social Sector Commissioning activity in 2020/21 undertaken by the Social Sector Commissioning Hub. This showed that:

- Commissioning of social services by government funders is split across 21 government
 agencies and Crown entities. It is common for each to focus on responding to the priorities of
 their Ministers, addressing their own portfolio issues, and implementing new initiatives.
- The sector includes an estimated \$6–7 billion in social supports and services through NGOs in more than 18,800 separate arrangements (including contracts, grants, and other funded agreements). There were over 5,800 providers involved in delivering services.
- The number of providers per government funding agency were as follows, noting there will be double counting where providers have arrangements with multiple government agencies:

IDI Data for Government Targets

Social Investment: evaluating social sector spending

Impact Reviews update

We continue to be on track to deliver initial advice to you in the first week of October 2024.

We are currently undertaking a close reading of the (more than 60) evaluations we have so far, in order to summarise what they are telling us about the impact of each programme.

We have completed a scan of the broader literature about what works in prevention/response for family violence and sexual violence (FVSV). We have successfully developed a method that involves subject matter experts using AI tools to synthesise large bodies of evidence, to extract maximum insight with least time investment. We are now applying this approach to a similar literature scan focused on what works in the first 2,000 days.

We have output our first tranche of data from the IDI across the two analytical projects focused on FVSV and the first 2,000 days. We are discussing these early findings with data experts across several agencies to ensure the insights are robust and actionable. We have attached some initial things we are seeing in this data.

We are working with our lead partners to develop a structured process to arrive at the investment advice we will give you in the report back in early October.

We have sent requests for additional information to agencies for the first 2,000 days review. This asks them to validate the information we have already collected, as well as filling in any missing gaps. We are also holding information sessions with agencies to discuss the review and support their participation. Te Puna Aonui has sent similar requests to agencies for the FVSV review, and are providing a system coordination and leadership role in the delivery of that review.

We are providing a slide pack that could be used to support the discussion about the Impact Reviews at the Social Investment Ministers meeting on 10 September. We are anticipating that, with the exceptions of Ministers Upston and Chhour, Social Investment Ministers are unlikely to have much knowledge of these reviews, and so the slides will provide the context, purpose and timelines for this work.

We have undertaken high level financial planning to inform our expected funding requirements and are currently engaging with the Treasury on a plan to draw down tagged contingency funding approved in Budget 2024. NCEA achievement

We have an ongoing cost-recovery relationship with Education Review Office (ERO) to support analytical work in the IDI. We will be supporting ERO to investigate the value of the NCEA Level 1 qualification. We will look at the life outcomes of 28 to 30 year-olds with varying levels of NCEA/NZQA attainment, to determine whether there is a benefit of attaining only NCEA Level 1 (but not higher levels of NCEA), relative to no school qualifications.

This work aligns with the strategic insights work we are undertaking with DPMC on Government Targets, in that the best available administrative proxy for the student achievement target (in Year 8) is performance in NCEA Level 1 (in Year 11). We expect to have initial insights towards the end of September and will share with you in due course.

Analytical approach for impact reviews

We are reviewing investment across two priority areas

We are examining the impact of investments supporting children in their first 2000 days; and recent investment in prevention or response to family or sexual violence. The purpose of this work is to identify opportunities for future investment decisions that align to the evidence about what works and for whom. These impact reviews are structured using the Social Investment Checklist recently developed by SIA (excerpt below).

OUTCOMES
 □ There is a discrete set of outcomes you are trying to achieve, and these are defined in terms of what people's lives would look like if the intervention is successful. □ The desired outcomes are measurable (indicators of the outcomes are defined). □ There is an ability to measure both immediate shifts and ultimate outcomes (and links between immediate and ultimate outcomes are logical and clear). □ IDEALLY: The outcomes are available across the whole population

 Evidence is available on specific (closely defined) groups that are not achieving or not likely to achieve the desired outcomes. There are operational opportunities to identify and better support these groups. Evidence on the experiences of these groups and on the factors contributing to the outcomes is articulated. IDEALLY: Partners have been identified that are close to the populations of interest and who can aid in designing and/or delivering services to them.

This work will be supported by SIA-led data analysis

We will use the Integrated Data Infrastructure (IDI) to provide advanced analytics enabling us to cover the 'outcomes' and 'who' sections of the Checklist. We have begun two analytical projects, each oriented around one of the priority areas. This will later be combined with insights arising from our assessments of impact, based on evaluation and monitoring of individual programmes, as well as our scan of the broader research literature on what works.

Our analyses aim to answer three core questions

- Who are the people the government should prioritise effective support for?
 This involves identifying a small target group of individuals/whānau for whom we have clear evidence of exceptional need for more effective support relating to the priority area.
- 2 How might we find these people?

 This involves identifying a group that is easily operationally identifiable (for example, the clients of a single agency, or a geographically-bounded community) that has the largest overlap with the priority group we have identified.
- 3. What are the benefits of better supporting these people?

 This involves describing what we know about the future needs and outcomes for the group we've identified, to provide evidence on the flow-on benefits of more effective support.






Emerging insights – First 2000 Days

Analysis for this priority area uses Adverse Childhood Experiences (ACEs) as a guiding framework, counting the number of ACEs experienced by children in the first five years of life.

Family violence	Any evidence of FV (Te Puna Aonui indicator)	10% of children
Sexual violence	Any evidence of SV (Te Puna Aonui indicator)	0.3% of children
Parents with substance abuse	Live with parents/caregivers who have specialist referral for alcohol/drug use	8% of children
Parents with mental illness	Live with parents/caregivers who have referral or diagnosis of serious mental illness	18% of children
Incarcerated parents	Parents/caregivers have custodial sentence spell	5% of children
Parental separation	Via various sources (Census, DIA, MSD)	28% of children

Need, as measured by ACEs, is increasing over time

We have identified two cohorts of children – those aged 5 in 2005, and those aged 5 in 2022. Relative to two decades ago, we can now identify many more children at the highest end of need, with four times as many five-year-olds having evidence of 4+ ACEs in 2022 than in 2005.



The ACEs that have experienced the biggest increases in prevalence over this time are children who have parents with evidence of serious mental health needs (7% to 18%), and children with evidence of exposure to family violence (3% to 10%). Some of this may be increases in coverage in administrative data, although the increase in mental health needs is mirrored in survey data.

We will demonstrate links between ACEs and adult outcomes

We plan on tracking the 2005 cohort forward to articulate the relationship between the number of ACEs experienced before the age of 5 and later life outcomes (across health, education, income, employment, and crime). We will then identify overlaps with the clients of various agencies, especially in the health, justice, and care systems.





Emerging insights – FVSV

We have combined four basic types of information to assemble a large dataset that describes the lives of people in ways that are relevant to their exposure to family/sexual violence.

Signals of FVSV

Drawn from:

- -Police
- -Courts
- -Corrections
- -Oranga Tamariki
- -Hospitalisations
- -ACC

Other signals of need

- -Offending and victimisation
- -Mental health/AOD
- -Employment
- -Education
- -Community



Relationships

- -People living in the same
- household
- Extended family who live nearby

We have analysed this rich dataset using cluster analysis, a statistical method that identifies subgroups of people who are alike on many different attributes. This method results in segmenting the entire NZ population into nine groups of increasingly higher need. These groups increasingly concentrate the people we have evidence are victims and those who use violence, but also people who are in whānau networks with others who use or experience violence.



Impact reviews

Research spotlight – impact of Best Start Payment on child abuse and neglect

Finding

Evidence of significant reductions in child abuse and neglect for some cohorts of New Zealand children are attributable to the Families Package

Description

Using the IDI, researchers at Auckland University have assessed the impact of the Families Package on measures of child abuse and neglect the first three years of life and found:

- an overall reduction of 19% in referrals to family group conferences in nonurgent cases of suspected maltreatment, but no significant differences in urgent cases.
 For Māori children and those for whom OT had previously recorded notifications of concern for older (half) siblings, the reduction was 26%.
- a 40% reduction in neglect among single-mother families.

This research provides evidence of improved social outcomes for New Zealand children attributable to the Families Packages (particularly the Best Start payment), beyond the immediate impact of increased parental income. The impact was greatest for Māori children, those living in high deprivation neighbourhoods, children in single-mother families and those who had siblings for whom OT had previously recorded notifications of concern. Experiencing abuse and neglect in early life has long term negative impacts on cognitive, psychological and health outcomes. As such, prevention of child maltreatment is likely to improve long term outcomes.

The findings of this research are consistent with emerging international evidence that rates of child abuse and neglect may be amendable to public unconditional cash transfers to families. Together, this evidence provides support for the efficacy of the Best Start

payment in supporting New Zealand families with young children, and could guide its targeting towards higher need cohorts.

We have shared this research with Treasury.



Along with Treasury, we met with officials from MHUD to discuss your questions on their paper seeking approval for a one-off funding transfer for emergency housing social outcomes contracting trial (HUD 2024-005349). We have been involved in prior conversations with MHUD on various aspects of the trial, including how outcomes might be measured in the IDI with reference to an appropriate comparison population. On the basis of the information gained through all of these discussions, we have assessed the MHUD proposal using the framework for social investment outcomes contracting that we are developing (with you for feedback) and consider that it meets all of the criteria to be considered a social investment outcomes contract. We continue to work with MHUD and Treasury to provide advice on the detailed design.

	Education Review Office – Evaluation of the Attendance Service

Description	The Education Review Office (ERO) is in the final stages of completing their evaluation of the Attendance Service. The report looks at how well the education system identifies the students who are chronically absent or not enrolled, and works with them and their families to get them attending school regularly.
	 We have contributed several analytical pieces over the course of the project to support ERO's fieldwork and survey of Attendance Services and Schools. Specifically, we have: undertaken rapid evaluation of the attendance service in the IDI (similar to our review of Alternate Education providers) answering the following questions:
	 What is the effectiveness of the Attendance Service, in terms of longer-term outcomes? Do estimates of effectiveness differ depending on type of student, or the type of provider? investigated what factors contribute most to chronic and regular attendance
	This report will be circulated to Ministers as it is being finalised. Over the course of the review, we have kept you updated on our findings and will look to brief you on the final report, once finalised.

Our analysis can also form the basis for understanding the potential impact of improvements in attendance service effectiveness, and could be used by the Ministry of

Education to model any proposed changes to the service.

Evaluation of services for students who are chronically absent from school

Status ERO are providing the first draft of the review to Minister Seymour this week

Description

The Education Review office is finalising its evaluation looking at the effectiveness and value for money of interventions aimed at getting chronically absent students back to school and keeping them there. The review was supported by the Ministry of Education and the Social Investment Agency. We supported this work through providing rapid evaluation of the Attendance Service within the IDI, which included:

- describing the characteristics and prior experiences of those that are referred to the attendance service,
- the effectiveness of the attendance service, in terms of longer-term outcomes
- cost to the Government of students with chronic absence compared to other groups.

Similarly to the findings from our evaluation of Alternate Education, we found the current Attendance Service model is not effective at creating sustained improvements in attendance. Outcomes for chronically absent students referred to the Attendance Service are worse than for a matched comparison group. The draft report is going to Minister Seymour's office this week and we will request a copy be provided to you, as appropriate.

Description

As discussed with you, we have been working with the Delivery Unit at DPMC to provide analytical support for reporting on Government Targets. As part of this work, we have developed a cross-cutting insights briefing (attached), based on IDI analysis.

The key findings of the work are:

- Around 1/3 of New Zealanders are in scope of the targets in a 12-month period.
- Most of these are confined to one target area and there is relatively little overlap in target populations outside of Health and Education.
- People who are the victims of crime or using Emergency Housing are more likely to appear in other targets, but half of them will not.
- People living in a household with recent family violence, receiving mental health treatment, or interacting with Oranga Tamariki Care and Protection are more likely to be in target populations but represent a small proportion of those populations.
- There is regional variation in target performance, with some regions indicated across the board. However, target achievement largely depends on success in the most heavily populated regions.

Future analysis could include identifying local 'hot spots' for focusing support to deliver outcomes aligned with one or more targets and identifying opportunities for early intervention with specific groups to reduce their likelihood of entering target populations. This analysis may also support the development of social investment initiatives for Budget 2025 and potential targets for the Social Investment Fund. We are working with DPMC to understand which future products would be most helpful for them and for lead agencies in supporting target delivery, at both the national and local levels.


	The analysis was limited by the availability of data in some key areas. We are working with Stats NZ to improve the quality and timeliness of IDI data relating to targets as a priority.





Status	We have produced some analysis looking at maternal mental health, which is due to be discussed at the upcoming Child and Youth Strategy Ministerial Group
Description	 The Child Wellbeing and Poverty Reduction Group (MSD) commissioned a short analysis on what we know about the group of young children whose mothers experience mental health issues. We found: Children of mothers with mental illness are 1.5 times more likely to have other adverse childhood experiences In particular, these children are 4 times more likely to experience sexual violence, 2.7 times more likely to have a father with mental illness, and twice as likely to have incarcerated parents Children of mothers with mental illness were much more likely to later experience negative outcomes by age 23, including serious youth offending, family violence, emergency housing, school non-attendance, imprisonment and benefit receipt.

The Child and Youth Strategy Ministerial Group are meeting on 3 December, where Ministers Upston and Doocey are leading a discussion on maternal mental health. It is planned that the SIA slides will be sent to the group in advance of the meeting, but the discussion will focus on effective approaches to maternal mental health, as opposed to the SIA analysis.

You have been invited to the Ministerial Group meeting and SIA officials will attend the meeting to support the discussion as necessary. We will share the report to you next week.



	SIA work with providers to develop a template contract and guidance is nearing completion, with discussions underway with these providers about next steps. It is anticipated that one provider will move straight into prototype contracting as part of joint work with MSD.

Infrastructure to support social investment

Status	Work progressing on test-and-learn projects to test data flows required for social investment contracts
Description	We are working with Stats NZ and a small number of providers to test the data flows required for managing outcomes contracts, including data required for impact measurement. The intention is to use the Integrated Data Infrastructure for this purpose and the SIA Data and Analytics Platform for reporting purposes. These 'test-and-learn' projects will begin early in the new year. In parallel, we are liaising with the Office of the Privacy Commissioner, Crown Law and the Stats NZ-led Data Ethics Advisory Group to make sure privacy and ethical practice are designed into this process from the outset.
